<p>The purpose of the course:  In this course, a student learns the handling system of the unnatural death in our country and knows the technique of the postmortem radiology diagnosis, the forensic autopsy.  And, a student deepen understanding about the social problems such as the forensic knowledge and sudden death that a physician should know, the pediatric forensic medicine, malpractice in medical practice.</p> <p>The arrival target of the course:  The student knows the current forensic circumstance and understands importance of the cause of death investigation.</p> <p>The summary of the course: The student can choose the following theme.</p> <ol style="list-style-type: none"> <li>1. A forensic science outline: We comment on forensic history and social role.</li> <li>2. The problems over the forensic autopsy system: We bring up the problems in the legal system over the forensic autopsy system of our country and comment on the need of the forensic autopsy.</li> <li>3. The handling and the postmortem examination of the unnatural death: We comment on knowledge of the necessary postmortem examination as a physician.</li> <li>4. A physician and law: We comment on the legal knowledge that a physician should know.</li> <li>5. Sudden death: We comment on the disease, the pathema to cause sudden death.</li> <li>6. Pediatric forensic medicine: We comment on the child abuse and neglect and sudden death in infant.</li> <li>7. Personal identification in the forensic medicine: The personal identification is required in the unidentified body. We comment the method of the forensic identification.</li> <li>8. Forensic radiology: We comment on forensic radiology diagnostic application such as CT, the panoramic dental X-ray system, ultrasonograph.</li> <li>9. Medical malpractice: We comment on medical-related death becoming the social problem.</li> </ol> <p>Also, other than a lecture, the student can choose a forensic autopsy visit, participation of the forensic CT conference, the participation of the case conference.  In the department of forensic sciences, we deal with personal information and investigation information about the forensic autopsy.  The student should adhere rigidly to confidentiality.</p>
